Nichirei Announces Posting of Extraordinary Losses and a Revision to Its Full-Year Results Forecast

Nichirei Corporation (the "Company") announces that it has posted extraordinary losses associated with losses caused by the Tohoku-Kanto Earthquake on March 11, 2011 and that it has revised its full-year consolidated results forecast for the fiscal year ended March 31, 2011, which was announced on December 21, 2010. Details are as follows.

2. Reason of the revision

Certain fixed assets, inventories, and other assets that the Group owns were damaged by the Tohoku-Kanto Earthquake. The Company has decided to post damages of ¥3,196 million, including estimates, as extraordinary losses.

With the posting of extraordinary losses, the Company has revised its full-year results forecast.
