Nichirei Corporation (the “Company”) announces the intermediate results of the acquisition of treasury stock made as part of the resolution passed at a meeting of the Board of Directors held on August 2, 2011 under Article 156 of the Companies Act, applied by reading the terms pursuant to the provision of Paragraph 3, Article 165 of the Act.
