Nichirei Corporation (the “Company”) announces the results of the acquisition of treasury stock made in accordance with the resolution passed at a meeting of the Board of Directors held on November 2, 2021 under Article 156 of the Companies Act, applied by reading the terms pursuant to the provision of Paragraph 3, Article 165 of the Act.
